3 A New Financial Concept

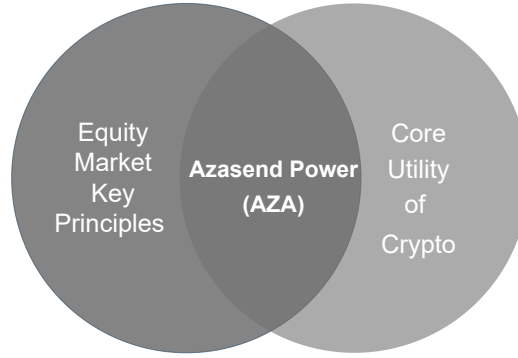


Figure 1: AZA Integration

This roadmap is subject to change based on evolving project goals and market conditions.

6.1 Phase 1: Earning AZA - From Q3/2024

Users can earn AZA for free through activities:

- Daily check-ins
- AZA Hunt
- Send to Earn incentives
- Giftbox and Blind Box

- Referral rewards

Users can mine even in phases 2, 3, and 4 but earning rewards decreases over time to ensure long-term scarcity.

6.2 Phase 2: Unlocking AZA - From Q2/2025

Dedicated users will be able to unlock AZA, promoting active participation. Unlocking will follow a schedule with multiple rounds. Unlocked AZA will be eligible for Profit-Sharing in Phase 4.

- Launch of unlocking features for users.
- Unlocking slots will be available at designated time frames.
- Users can apply for slots based on the number of AZA they hold.

Slots are allocated on a first-come, first-served basis until all slots for the time frame are filled.

6.3 Phase 3: AZA Value Management - From Q3/2025

As Azasend continues to grow, ensuring the long-term stability and value of AZA is a top priority. Phase 3 focuses on establishing dynamic valuation models and implementing strategic mechanisms to define AZA's value.

- Establish dynamic valuation models
- Implement strategic mechanisms to define AZA value.
- Users can participate in shaping AZA value management strategies by voting and governance.

The more AZA a user holds, the greater their voting power, allowing committed holders to have a stronger influence on platform decisions.

6.4 Phase 4: Profit-Sharing and Growth - From Q4/2025

Azasend encourages long-term holding by integrating profit-sharing mechanisms that benefit engaged users who actively participate in Azasend's growth.

- Qualified users who hold and contribute to the ecosystem will receive **profit distribution** based on platform-defined valuation.
- Bidding-based priority system will be implemented, ensuring that users who actively contribute to AZA and Azasend Exchange Growth receive proportional rewards.

7.1 Allocation Strategy

- Maintain a sustainable check-in mechanism for long-term distribution
- 50% of AZA are dedicated to user unlocks, enabling active participation and growth within the ecosystem. 50% will be allocated to the community, strategic partners, marketing, the project team, and the reserve fund, ensuring continued innovation, support, and platform stability.

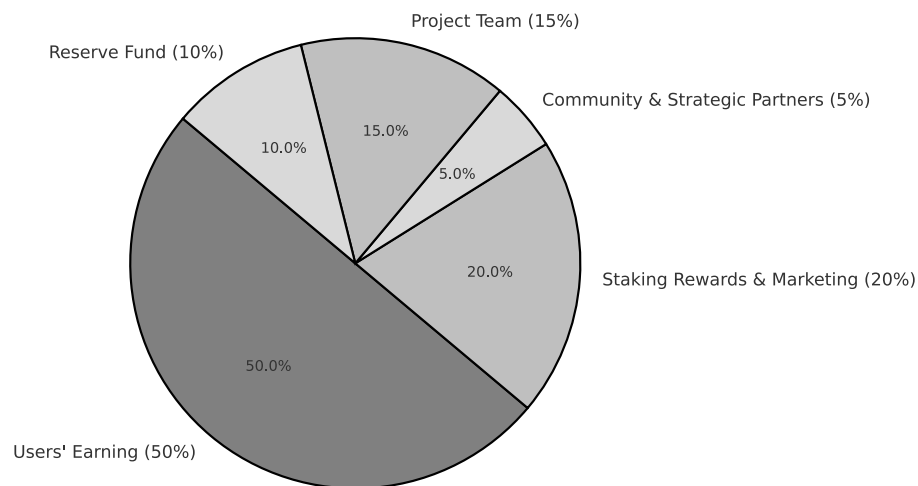


Figure 2: AZA Allocation
